Findings:

- Due to the significant involvement of CInMED and external researchers in the work related to the COVID 19 pandemic, project activities belonging to work package 4 (WP4) are expected to be delayed.
- CInMED researchers and external researchers are working on generating DEV (OUTPUT) 4.1 after which MG SOFT should prepare DEV (OUTPUT) 4.2 and DEV (OUTPUT) 4.3.
- It was emphasized that it is necessary to communicate with the Health Insurance Fund and obtain approval from the Ministry of Health regarding the implementation of warning messages for the rational prescribing of diclofenac in IS Primary Healthcare.
 CFCU On-the-spot verification for Grant Contract has been announced for 27.05.2021. on which occasion the documentation of CInMED and MGSOFT that will be subject to verification was checked.
- It was concluded that the project activities are carried out in accordance with the plan and that there are currently no problems that significantly affect the implementation of the project.




