Findings:

In preparation for the meeting, CInMED sent a document with additional requirements in order to generate reports necessary for the preparation of defined outputs.

MG-Soft stated that the requirements cannot be realized within the framework of the established Datawarehouse model, i.e. that the required reports cannot be generated through because these requirements go beyond the settings of the project solution that is defined in the first part of the project.

The proposal is to extract a set of data from the data source (DZ), but not directly into DW but into excel so that the analysis would be performed outside of the developed BI software.

The proposal is to submit two excel files with a specific type of data that are requested in the CInMED request and that CInMED would send to the statisticians for processing.

MG-Soft will look into the possibility of implementing these activities and inform CInMED during the next week.

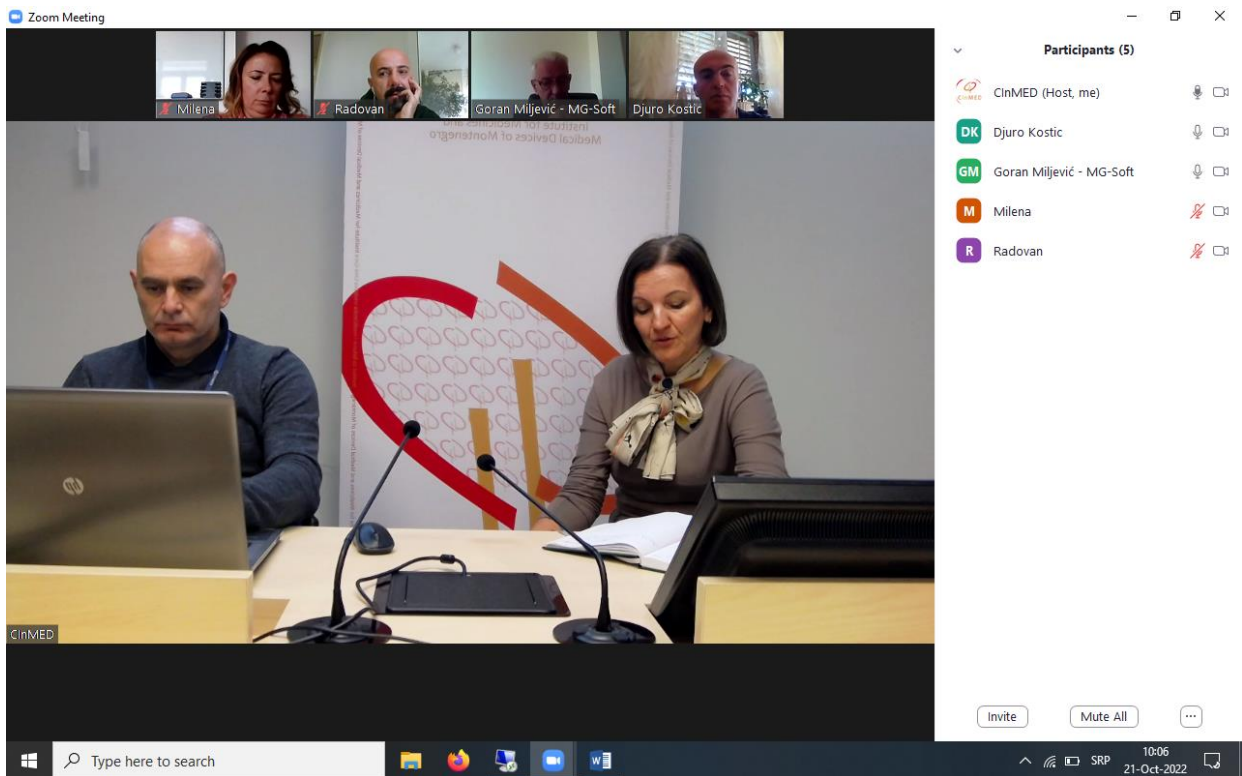
